THE FAMILY PROMISE NETWORK SHELTERS WORKING FAMILIES WITH DEPENDENT CHILDREN WHO ARE HOMELESS AT LOCAL CONGREGATIONS OVERNIGHT. ONCE THE IMMEDIATE NEEDS OF FOOD AND SHELTER ARE MET, FOCUS IS PLACED ON HELPING FAMILIES LEARN NEW JOB SKILLS AND FIND SAFE, AFFORDABLE CHILDCARE AND TRANSPORTATION. ALL FAMILIES TAKE PART IN FINANCIAL LITERACY CLASSES AND A MANDATORY SAVINGS PLAN. THEY RECEIVE HELP WITH BASIC COMPUTER SKILLS, GED PREPARATION, JOB READINESS, DRIVER'S EDUCATION, ESL AND POSITIVE PARENTING TECHNIQUES. INTENSIVE CASE MANAGEMENT IS KEY TO THIS PROGRAM. UTILIZING VOLUNTEERS IN THIS PROGRAM IS COST-EFFECTIVE AND DIRECTLY CONNECTS FAMILIES IN THE COMMUNITY WITH THOSE IN NEED. THIS CREATES A BETTER UNDERSTANDING OF THE VULNERABILITY OF SOME LOCAL FAMILIES AND THE CAUSES OF HOMELESSNESS.

APPLICANTS MUST BE EXTREMELY MOTIVATED TO IMPROVE THEIR LIVES AND THAT OF THEIR CHILDREN AND CAN DEMONSTRATE THEIR COMMITMENT TO MAKING THIS A REALITY. WE PROVIDE A HOLISTIC APPROACH TO ADDRESSING THE NEEDS OF THESE FAMILIES. EVERY NIGHT OF THE YEAR, FAMILY PROMISE VOLUNTEERS PROVIDE, PREPARE AND SERVE UP TO 150 DINNERS FOR HOMELESS AND/OR NEEDY INDIVIDUALS. THE ESTIMATED COST OF THE MEALS THAT HAVE BEEN PROVIDED APPROXIMATES \$5 MILLION. IN 2015, 38,980 MEALS WERE SERVED, AN INCREASE OF 6,591 MEALS AS COMPARED TO 2014. THIS NUMBER INCLUDES THE 80 RESIDENTS OF THE BERGEN COUNTY HOUSING, HEALTH AND HUMAN SERVICES CENTER WHERE THE MEALS ARE SERVED EACH NIGHT.
