THE FAMILY PROMISE NEW LEAF PROGRAM OFFERS TEMPORARY HOUSING, GENERALLY FOR UP TO TWO YEARS, FOR HOMELESS FAMILIES, INCLUDING SOME WHO WERE IN THE FAMILY PROMISE NETWORK. APPLICANTS MUST BE EXTREMELY MOTIVATED TO IMPROVE THEIR LIVES AND THAT OF THEIR CHILDREN AND CAN DEMONSTRATE THEIR COMMITMENT TO MAKING THIS A REALITY. WE PROVIDE A HOLISTIC APPROACH TO ADDRESSING THE NEEDS OF THESE FAMILIES. ON AN INDIVIDUALIZED BASIS, THIS PROGRAM INCLUDES JOB TRAINING, CONTINUING EDUCATION, WORKPLACE READINESS INSTRUCTION, FINANCIAL LITERACY TRAINING, PARENTING SUPPORT AS WELL AS HELP REMOVING ADDITIONAL BARRIERS TO EMPLOYMENT. THE GOAL OF THIS PROGRAM IS NOT MERELY TO RETURN TO HOUSING BUT TO ENSURE THAT FAMILIES ARE SELF-SUFFICIENT UPON COMPLETION. OUR RECIDIVISM RATE IS VIRTUALLY ZERO.

THE FAMILY PROMISE NETWORK SHELTERS WORKING FAMILIES WITH DEPENDENT CHILDREN WHO ARE HOMELESS AT LOCAL CONGREGATIONS OVERNIGHT. ONCE THE IMMEDIATE NEEDS OF FOOD AND SHELTER ARE MET, FOCUS IS PLACED ON HELPING FAMILIES LEARN NEW JOB SKILLS AND FIND SAFE, AFFORDABLE CHILDCARE AND TRANSPORTATION. ALL FAMILIES TAKE PART IN FINANCIAL LITERACY CLASSES AND A MANDATORY SAVINGS PLAN. THEY RECEIVE HELP WITH BASIC COMPUTER SKILLS, GED PREPARATION, JOB READINESS, DRIVER'S EDUCATION, ESL AND POSITIVE PARENTING TECHNIQUES. INTENSIVE CASE MANAGEMENT IS KEY TO THIS PROGRAM. UTILIZING VOLUNTEERS IN THIS PROGRAM IS COST-EFFECTIVE AND DIRECTLY CONNECTS FAMILIES IN THE COMMUNITY WITH THOSE IN NEED. THIS CREATES A BETTER UNDERSTANDING OF THE VULNERABILITY OF SOME LOCAL FAMILIES AND THE CAUSES OF HOMELESSNESS.

EVERY NIGHT OF THE YEAR, FAMILY PROMISE VOLUNTEERS PROVIDE, PREPARE AND SERVE UP TO 150 DINNERS FOR HOMELESS AND/OR NEEDY INDIVIDUALS. THE ESTIMATED COST OF THE MEALS THAT HAVE BEEN PROVIDED APPROXIMATES \$5 MILLION. IN 2016, 47,125 MEALS WERE SERVED. THIS NUMBER INCLUDES THE 80 RESIDENTS OF THE BERGEN COUNTY HOUSING, HEALTH AND HUMAN SERVICES CENTER WHERE THE MEALS ARE SERVED EACH NIGHT.
