ADDITIONAL TO-GO MEALS WERE PROVIDED TO MEMBERS OF THE COMMUNITY WHO CAME TO THE SHELTER SEEKING A NIGHTLY MEAL. FPBC CONTINUED THIS MODEL IN 2021 PROVIDING 50,000 MEALS TO THOSE IN NEED. SINCE ITS INCEPTION IN 1991, THE FAMILY PROMISE WALK-IN DINNER HAS SERVED OVER 1.25 MILLION MEALS TO VULNERABLE ADULTS, FAMILIES AND CHILDREN VALUED AT APPROXIMATELY \$6.25 MILLION. THIS IS ESPECIALLY TRUE, AS RENTS HAVE SKYROCKETED SINCE THE BEGINNING OF THE COVID PANDEMIC. FUNDING IS AVAILABLE FOR RENT, RENTAL ARREARS, UTILITY BILLS AND SERVICES DESIGNED TO ALLOW FAMILIES TO REMAIN IN STABLE HOUSING. FAMILIES ACCEPTED INTO THIS PROGRAM MEET WITH CASE MANAGERS AND ARE ABLE TO PARTICIPATE IN ADDITIONAL ACTIVITIES TO SUPPORT THEIR CONTINUED SUCCESS MAINTAINING STABLE HOUSING.
